## **Carbon Reduction initiatives**

- 1. Energy Efficiency:
  - a) One Stop Pharmacy will Implement energy efficient lighting systems such as LED bulbs and motion sensors to reduce electricity consumption
  - b) We will regularly maintain and upgrade HVAC systems to optimize energy efficiency.
  - c) Encourage employees to power off equipment and devise when not In use.
  - d) Conduct regular energy audits to identify areas for improvement and track progress.

## 2. Waste Management:

- a) Adopt a comprehensive waste management system, including recycling, composting and proper disposal of hazardous waste materials. One Stop Pharmacy contract out the recycling of all card-board boxes used to B&M waste management services.
- b) Educate employees about waste reduction techniques and encourage them to follow recycling and waste management guidelines.
- c) Promote the use of reusable materials and minimize single use plastic in the workplace.
- d) Partner with Waste management organisations' that prioritise environmentally friendly practices.

#### 3. Sustainable Product Procurement

- a) Collaborate with suppliers who prioritize sustainability and have eco-friendly processes in place. One of our main logistics suppliers is LNE&F logistics and they are also committed to achieving and reducing their carbon emissions.
- b) Prioritise the procurement of products with sustainable packaging and reduced carbon footprints.
- c) Incorporate green procurement polices that consider the environmental impact of products and encourage the use of recycled or eco-friendly alternatives.

#### 4. Transport and logistics

- a) Encourage employees to use public transportation, carpool, or bike to work whenever possible.
- b) Optomise transportation routes to reduce fuel consumption and carbon emissions.
- c) Promote virtual meetings and telecommuting to minimise travel needs.
- d) Utilise fuel efficient and for delivery purposes or investigate the possibility of electric vehicles and or hybrid vehicles for delivery.

## 5. Employee Engagement and training

- a) Establish an internal committee to monitor and implement carbon reduction initiatives.
- b) Conduct regular training sessions to educate employees about carbon reduction strategies.
- Recognise and rewards employees who actively participate in and support our carbon reduction efforts.

# 6. Monitoring and reporting:

- a) One Stop Pharmacy will regularly monitor and measure energy consumption, waste generation and carbon emissions.
- b) We will set specific targets and timelines for carbon reduction, waste reduction and energy efficiency improvements.
- c) We will commit to publishing an annual sustainability report to communicate to stakeholders and trusts our progress and achievements to stakeholders.
